Policy for Best Researcher Award Implementation (Diploma)

Preamble: Since 1983 RIT has witnessed lot of success and developments in different areas. However, in Research and development additional efforts are required. Usually academic assignments and work is time bound. In contrast, R & D work requires more efforts and time for completion. For completion of R & D work, it may be necessary to work beyond working hours. Therefore, to encourage faculty for undertaking research activity and work beyond working hours. effective system and procedure should be devised and implemented.

Best researcher award can be effectively used to boost R & D activities at the Diploma. In order to engage faculty in R & D work, it is essential to appreciate and recognize additional efforts taken by them. In addition, if industry institute interaction is enhanced then it may improve student placement to some extent. The system and procedure for Best Researcher award should be made in such way that it overcomes weakness of Diploma in R & D activities to large extents. The following points are to be taken into consideration for devising procedure for Best researcher award implementation.

- 1. The scheme for evaluation of R & D work should be objective and transparent.
- 2. The marks allocated to each component of R & D work should be according to increasing difficulty level.

Procedure for Best Researcher award implementation

The following policies have been put in place to create superior research environment: -

- 1. R & D work can be subdivided into following seven components
 - a. Publications
 - b. Guiding Interdisciplinary Projects
 - Internally seed funded research
 - d. Industry institute interaction
 - Externally funded Research
 - Patent
 - g. International/National conference awardees



- 2. Faculty can score unlimited marks in R & D work for different components.
- 3. To become eligible for award,
 - Faculty should score at least 25 marks in R & D work.
 - Faculty must publish one H-indexed paper or bring external research funding or file at least one patent apart from other R&D work.
- There shall be healthy competition among faculty for winning Best Researcher award.
- 5. Top two scorers from Diploma shall be selected for Best Researcher awards.
- Top scorer from Diploma shall be given cash prize of Rs. 3,000/and second scorer shallet cash prize of Rs. 2,000/ālong with certificates. However, if top scorer from diploma scores below 35 then faculty shall get cash prize of Rs. 2,000./—
- The R&D achievements falling in between 1st July to 30th June shall be considered for award.
- Faculty who has received second prize can submit nomination for first prize in next academic year. However, faculty must score more than 60 marks to become eligible for first prize from the diploma.
- Faculty who has received first prize will become eligible to submit nomination after two year.

- 1. Faculty can score separate marks for each published paper.
- First author of the paper can claim 100 % marks of the achieved level. Second author shall claim 60 % marks. However, third, fourth, fifth author in the paper shall claim 30 % marks of the achieved level.
- 3. Publication in conference proceeding having H-index will not be considered for award.
- 4. Publications in JEET journals shall be considered for award only if faculty has at least one

H-indexed publication in technical domain.

- 5. Publications in paid H-indexed journals shall not be considered for award.
- 6. Publications in paid UGC listed journals shall not be considered for award.
- Accepted Paper shall be considered.
- 8. Publication must have name of the institute in the affiliation.
- 9. Evaluation committee has final rights to consider publication for award.

- First author/presenter of the paper can claim 100 % marks of the achieved level. Second author/presenter shall claim 60 % marks. However, third, fourth, fifth author/presenter in the paper shall claim 30 % marks of the achieved level.

- If the publication is achieved from in-house seed funded project, then faculty shall claim marks in both Publications and internally funded Research components.
- Co-principal investigator of the project must claim 60 % marks of the achieved level.
- R&D cell will take review of in-house seed funded projects every year. R&D cell after review will give the final marks based on quality of work.
